

Instructions for use: Create your contest functionary packets by printing the labels in this file and applying them to manila folders. This will make your contest easier to prepare for and more organized. Since the Toastmasters International item numbers vary based on contest type, a folder label set is provided for each of the District 38 contests. The label stock is Avery #5163/8363 (also available as Staples SIWJ130), 2"x4" white shipping labels. At the bottom of the file is a page of labels which should be printed and applied to the envelopes used to collect records from various functionaries.
